# **2020 Turkey Season Dates**

#### **Special Youth Turkey Hunt**

**Statewide:** April 11-12, refer to WMA pages 23-32 for WMA dates.

Only hunters 6 to 15 years old may hunt turkeys during the special youth turkey hunt. Youths who have completed hunter education may hunt alone. Youths who have not completed hunter education must be under the direct supervision of an adult who is 21 or older.

#### Turkey Season Dates and Harvest Limits

Zones 1, 2, 3, 4B, 5, 5B, 6, 7, 7A, 8, 9, 10 and 17: April 13-28

Two legal turkeys, no jakes.

Zones 1A, 4, 4A, 5A and 9A: April 13-21 One legal turkey, no jakes. Hunters who kill a turkey in one of these zones must travel to any other zone (including other one-bird-limit zones) to harvest a second turkey.

#### Statewide Turkey Bag Limit

The statewide bag limit is two legal turkeys, no jakes. Hunters 6 to 15 years old may harvest one jake as part of their two-bird limit during the season (including the youth hunt). **Hunters may not exceed any zone harvest limits.** No more than one legal turkey may be taken per day.

# What Is a Legal Turkey?

#### A turkey may be considered legal under the following rules:

A legal turkey is an adult gobbler or bearded hen. Only hunters 6 to 15 years old may harvest one jake as part of their two-bird limit during the season (including the youth hunt). See Page 5 for jake identification.



# How to Identify a Jake Turkey



#### A jake is a male turkey with all these characteristics:

- 1. Outermost wing feathers lack white barring all the way to the tip.
- 2. The central tail feathers are longer than the rest.
- 3. The beard is 6 inches or shorter.

# An adult gobbler is a male turkey with at least one of the following characteristics:

- $1. \ \mbox{Wing feathers have white barring all the way to the tip.}$
- 2. Tail feathers are the same length.
- 3. The beard is longer than 6 inches.





# **2019 Turkey Harvest Report**

#### **Turkey Harvest Report**


The 16-day 2019 turkey season began April 8 and ended April 23 in most of Arkansas's turkey zones. A special youth turkey hunt was held April 6-7. Bag limits were unchanged from recent years – a two-gobbler limit, with youth allowed to harvest one jake. Some zones had a restricted nine-day regular season and a onegobbler bag limit.

Hunters checked 8,217 turkeys in 2019, a 4 percent increase from the 2018 season (7,884 checked birds). During the two-day youth hunt, youths harvested 691, up from 630 birds in 2018. Archers checked 30 turkeys; crossbow hunters checked 12; hunters using muzzleloading shotguns checked six. Jakes made up 2.7 percent of the harvest, compared to 22 percent, the average jake harvest from 2000-2010.

# **Hunting Licenses and Costs**

Combination Resident Sportsman's License (CS) \$35.50	Entitles the holder to hunt all game species using modern gun, muzzleloader or archery, and to take a total bag limit of deer. Also allows the holder to hunt furbearers and to fish the waters of the state with sport fishing tackle. TP required to trap furbearers. A Resident Trout Permit also must be purchased to retain trout or to fish in certain waters. Valid through June 30. Six deer tags and two turkey tags are included with this license.
Resident Sportsman's License (RS) \$25	Entitles the holder to hunt all game species using modern gun, muzzleloader or bow, and to take a total bag limit of deer and turkey. Expires June 30.
Nonresident Annual All Game Hunting License (NBG) <b>\$350</b>	Entitles the holder to hunt all game species using modern gun, muzzleloader or bow, and to take a total bag limit of deer, bear and turkey. Expires June 30.
Nonresident Five-Day All Game Hunting License (AG5) <b>\$180</b>	Entitles the holder to hunt all game species for the five-day period specified. Three game tags are included with this license. (Only two may be used for turkeys).
Nonresident Three-Day All Game Hunting License (AG3) <b>\$125</b>	Entitles the holder to hunt all game species for a three-day period specified. Two game tags are included with this license.
Nonresident One-Day All Game Hunting License (AG1) <b>\$55</b>	Entitles the holder to hunt all game species for the one-day period specified. One game tag is included with this license.
WMA General Use Permit (WMP) <b>Free</b>	Required to hunt or trap on WMAs. May be obtained at www.agfc.com or 800-364-4263 or any regional office.
Voluntary Turkey Stamp (TS1) <b>\$9.50</b>	May be obtained anywhere licenses are sold, www.agfc.com or 800-364-4263.

#### Licenses and permits are nontransferable and nonrefundable.

# Other Resident Licenses Valid for Turkey Hunting

- Three-Year Disability Hunting or Combination licenses available to disabled resident hunters who meet certain criteria: or
- 2. 65 Plus Resident Lifetime Hunting or Combination licenses, Resident Military Retiree Lifetime Licenses and Resident Disabled Military Veteran Lifetime Licenses; or Combination licenses available to hunters over 65 who provide proof of age and 60 days current Arkansas residency; or
- Nonexpiring Lifetime Hunting and Fishing Sportsman's Permit (\$1,000). Contact the AGFC at 501-223-6388 for more information.
- 4. 65 Plus Annual Sportsman's License (\$3.50).

#### How do I buy a license?

Licenses are available over the counter at AGFC regional offices (see Page 1) and nature centers, sporting goods stores, hunting and fishing supplies stores across the state.

to supply personal information and a credit card
number. You will be able to print your license on
your home printer upon completion. You will be
able to replace any lost license from this site also.
Telephone and online purchases must be made

by credit card. Small game and fishing privileges become effective immediately. A valid printed license or **acceptable electronic format** license must be in your possession before hunting turkey. Lifetime, disability and commercial licenses are not available by phone or online.

#### Who needs a Hunter Education card?

A hunter born after 1968 must carry a valid hunter education card, unless "HE-VERIFIED" is noted on your hunting license.



Hunters under 16 do not need to have a card if they are under the direct supervision of an adult at least 21 years of age and possesses valid hunter education certification, or who was born before 1969. Arkansas honors the home state hunter education cards of nonresidents. Call 800-482-5795 or check www.aqfc.com for a class schedule.

# **Turkey Permit Hunts**

Hunting is allowed on several wildlife management areas and national wildlife refuges only during special permit hunts to manage turkey populations and prevent crowding. Permit holders can be accompanied by a nonhunting individual during a permit hunt. The nonhunting individual may only call for the permit holder.

Visit www.agfc.com from Jan. 15 until Feb. 15 to apply for a permit turkey hunt on a WMA. For MWRs refer to fws.gov/refuges.com

# **Mobility-impaired Access Permits**

Mobility-impaired access permit holders may use an ATV on Commission-owned WMAs, Big Timber WMA, Jack Mountain WMA and Moro Big Pine Natural Area WMA to travel on graveled, all-weather roads (unless posted closed to vehicles) and on designated mobility-impaired access trails.

Hunters with the following conditions may call 800-364-4263 during business hours or visit an AGFC regional office (Page 1) for a mobility-impaired access permit application:

- A permanent physical condition requiring the use of a brace, cane, crutch, prosthetic device, wheelchair or walker
- Permanent lung disease which severely restricts respiration to the levels stipulated on the application form
- A permanent physical condition requiring portable oxygen
- A permanent cardiac condition classified as Class III or IV by the American Heart Association

#### **Leased Land Permits**

Permits are available for \$40 which entitle the holder to hunt, trap and camp on leased land WMAs: Big Timber WMA, Casey Jones WMA, Cherokee WMA, Gum Flats WMA, Howard County WMA, Jack Mountain WMA, Jim Kress WMA, Lafayette County WMA, Lake Greeson WMA and Provo WMA. Each leased land WMA requires a separate permit.

Youths under 16 are not required to have a permit. Permits are valid for one year from the date of purchase. Permits available at any license dealer or AGFC office or www.agfc.com.

Hunters must get permission from landowners to travel through neighboring private lands.

## **WMA General Use Permits**

A free annual permit is required for persons 16 years and older to hunt or trap on WMAs. Permits are available online at www.agfc.com or by calling 800-364-4263 or any regional office.

Information obtained from the permit will be used to survey hunters on a variety of issues such as hunt quality and specific biological information. See pages 22-23 for map of WMAs.

# **Turkey Regulations Summary**

- Only shotguns (10 gauge and smaller) and archery equipment (including crossbows) are legal for turkey hunting. Shot larger than No. 2 common shot is prohibited.
- · Shooting a turkey from a boat is illegal.
- Turkeys may not be taken from 30 minutes after sunset until 30 minutes before sunrise.
- Hunting within 100 feet of the center of a city, county, state or federally maintained road or any open road on a WMA is illegal. Check the area notes of your WMA for exceptions.
- Firearms must be unloaded and cased while being transported by boat from 30 minutes after sunset until 30 minutes before sunrise.
- Turkeys may not be hunted with the use of traps, snares, nets, hooks, explosives, dogs or live decoys.
   Hunters may not possess electronic or mechanically powered or driven callers.
- During youth turkey hunts, coyote and bobcat hunting is open only to youth hunters.
- Hunting or shooting across the main west levee of the Mississippi or Arkansas rivers from the Louisiana-Arkansas state line to the intersection of Arkansas Highway 11 is illegal.
- Hunters must be at least 6 years old to harvest a wild turkey.
- Releasing domestically reared turkeys into the wild is illegal.

- Capturing wild turkeys or collecting their eggs is illegal.
- Wild turkeys may not be hunted over bait. An area is considered baited if any food (including shelled, shucked or unshucked corn, chops,wheat or other feed that could serve as a lure or attractant for wildlife) is present or has been present in the last 10 days. (An area is considered baited for 10 days following complete removal of the bait.) A hunter is liable for a baiting violation if he or she knows, or reasonably should know, that the area is or has been baited, even following complete removal of bait. There is no set distance from a baited site that a hunter may shoot a turkey.
- Each WMA is a separate zone for which the Commission may establish and apply hunting regulations. Private land that is completely surrounded by WMA land is subject to the same hunting season dates, hunting hours, bag limits and hunting permits as the surrounding WMA.
   EXCEPTION:

Private land completely surrounded by National Wildlife Refuge or Arkansas Natural Heritage Commission land is subject to the same hunting season dates, hunting hours, bag limits and hunting permits as the surrounding or nearest adjacent state management zone, plus any federal regulations pertaining to NWR or ANHC.

# **Private Property and Residences**

#### **Hunting Near a Residence**

Hunters lawfully present through ownership or lease agreement may hunt on their own property, regardless of distance to another person's residence.

However, all other hunters using firearms within 150 yards of a residence or using archery equipment within 50 yards of a residence must have written permission from the owner or occupant of that residence.

#### **Hunting on Private Property**

Written permission (see example on Page 12) from the landowner or leaseholder is required before hunting, fishing, trapping or releasing hunting dogs or pursuing wildlife with dogs on private property.

Written permission is not required if the person hunting is a relative (spouse, parent, child, sibling, uncle, aunt, son or daughter-in-law, niece, nephew, grandchild, or grandparent of owner) of the landowner or leaseholder and permission can be verified.

# **Transferring Wildlife**

# Transferring fish or wildlife to another person?

If you give all or part of your game to another person, you must give that person all information listed on the sample tag (Page 12). Hunters under 16 may use a hunter education card number or date of birth instead of the license number.

# Hunting Camp and Commercial Processing Records Requirements

Hunting camps, commercial butchers, processors, cold storage facilities, fur buyers and taxidermists must maintain legible records of all information listed on the sample tag (Page 12) for all wildlife and parts thereof in their possession. These records must be maintained and available for one year from the date taken.

# **Turkey Tagging and Checking Requirements**

#### **Checking a Turkey by Phone or Online**

Use the zone map on Page 5 for turkeys harvested on private land. Use the zone map on pages 22-23 for turkeys harvested on public lands.

**Option 1.** Immediately upon harvest (before moving turkey), check turkey via **www.agfc.com**, the AGFC mobile app or by calling **877-731-5627**.

Option 2. Follow both steps below:

- Step 1. Fill out a game tag from your license or the one provided on Page 12. Complete all information, except Check #, legibly and in ink. A game tag also may be created from any material that includes the hunter's name, customer ID number and the date, time and zone of harvest. Fasten the tag to the leg of the turkey.
- **Step 2.** Check turkey via www.agfc.com, the AGFC mobile app or by calling 877-731-5627 within 24 hours of harvest. (Note check number on game tag.)

Checked game does not require a tag as long as the turkey remains in the hunter's immediate possession. If the animal is left at a processor or other facility before point of final storage, harvest information reflecting the name, address, species, sex, date taken and check confirmation number must remain with all portions

Entrails may be removed, but evidence of the animal's sex must remain until checked.

#### No turkey may be transported across state lines before being checked

If you choose to give away all or a portion of your game after it has been checked, you must use a game transfer form (Page 12).
